

WORK DAY WAIVER OF LIABILITY AND RIGHT TO USE IMAGE

MINOR CHILDREN (UNDER 18) WAIVER: I/we fully understand and appreciate the risks, no matter how remote, that may be attendant to activities for which my/our child has agreed to volunteer, and in consideration of the opportunity afforded to my/our child to assist on a voluntary basis with FOCUS ON CANTON, and in light of the aims and purposes of the community services provided by FOCUS ON CANTON, I/we (print Parent(s) or Legal Guardian(s) names _____,

on behalf of my/our child, hereby waive to the fullest extent permissible by law any and all rights and causes of action arising out of, relating to or as a result of my/our child's participation in the Work Day that I/we may have against FOCUS ON CANTON, its volunteers, officers, directors, participants, donors, respective heirs, executors, administrators and assigns, collectively and individually. Without limiting any of the above, I/we agree that this MINOR CHILD WAIVER OF LIABILITY includes any rights and causes of action arising out of, relating to and as a result of bodily harm or personal injury my/our child might sustain in my/our child's voluntary involvement in the Work Day.

ADULT WAIVER OF LIABILITY: I fully understand and appreciate the risks, no matter how remote, that may be attendant to activities for which I have agreed to volunteer, and in consideration of the opportunity afforded me to assist on a voluntary basis with FOCUS ON CANTON, and in light of the aims and purposes of the community services provided by FOCUS ON CANTON, I hereby waive to the fullest extent permissible by law any and all rights and causes of action arising out of, relating to or as a result of my participation in the Work Day that I may have against FOCUS ON CANTON, its volunteers, officers, directors, participants, donors, respective heirs, executors, administrators and assigns, collectively and individually. Without limiting any of the above, I agree that this WAIVER OF LIABILITY includes any rights and causes of action arising out of, relating to and as a result of bodily harm or personal injury I might sustain in my voluntary involvement in the Work Day.

I/we, on my/our behalf and/or on behalf of my/our minor child, hereby expressly and specifically assume the risk of personal injury or bodily harm and do further expressly release, hold harmless and indemnify FOCUS ON CANTON from all liability for personal injury, bodily harm, illness, death or property damage resulting from or arising out of the activities.

I understand that FOCUS ON CANTON may take photographs or video recordings during the event and I acknowledge that my image, or if applicable, that of my minor child(ren) named below may be captured incidental to participation in this event. I waive any rights to such images, recordings or materials and hereby allow FOCUS ON CANTON to use the images for promotional use in keeping with the spirit of the event and release FOCUS ON CANTON from any claims, damages or liability arising from or related to such use.
